BENEFITS PREPAID CARD

Technology that enables members to access multiple benefits, balances and catalogs tied to a single card.

How does it work?

- The Benefits Prepaid Card is loaded with spending amount(s) directly on the card (monthly, quarterly, annually) and works just like a prepaid credit card.
- Begin shopping as soon as you plan coverage
- Member chooses how to order and fulfill their needs with in-store network retailer, online or phone orders

What can it be used for?

- Use to purchase eligible items within the approved benefit(s) and retailer network for OTC, Healthy Groceries, various Flex Accounts, Assistive Devices and Service Dog
- Retailers –Walmart, Kroger, CVS, Rite Aid Giant Eagle, etc.

What else?

- Card cannot be converted to cash
- Card format will be Mastercard for all benefits resulting in easier/more intuitive user experience
- New online ordering experience
- No shipping costs and 2-day delivery
- One Integrated Call Center, all benefits through Member Service number on the card

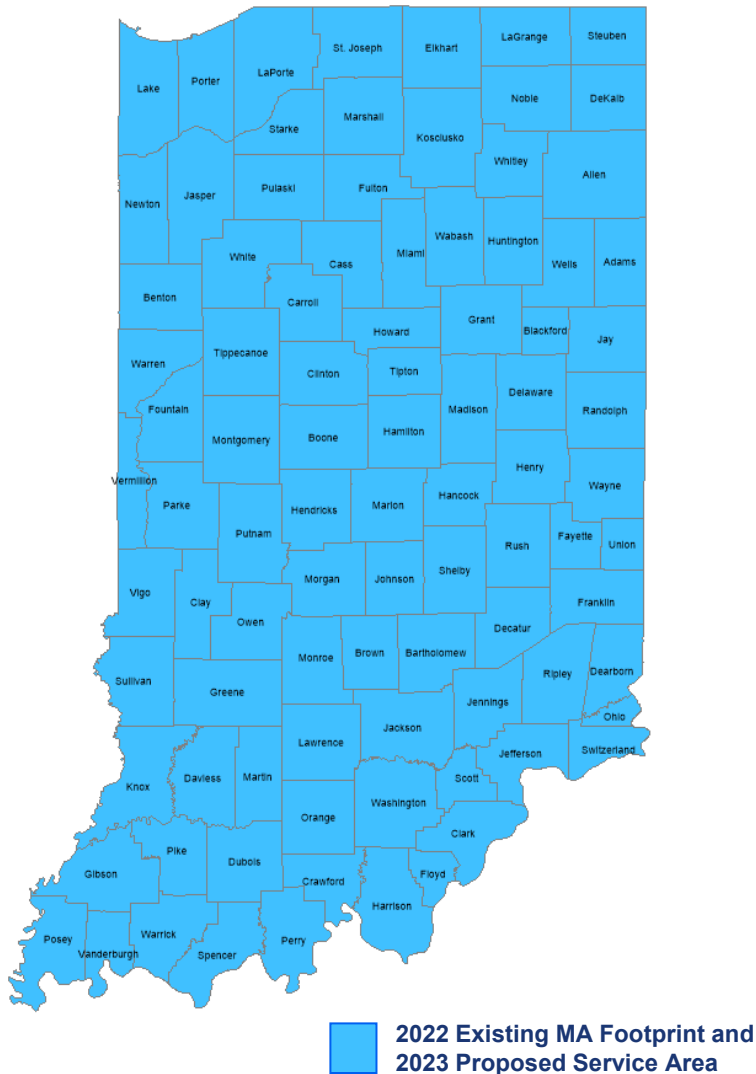

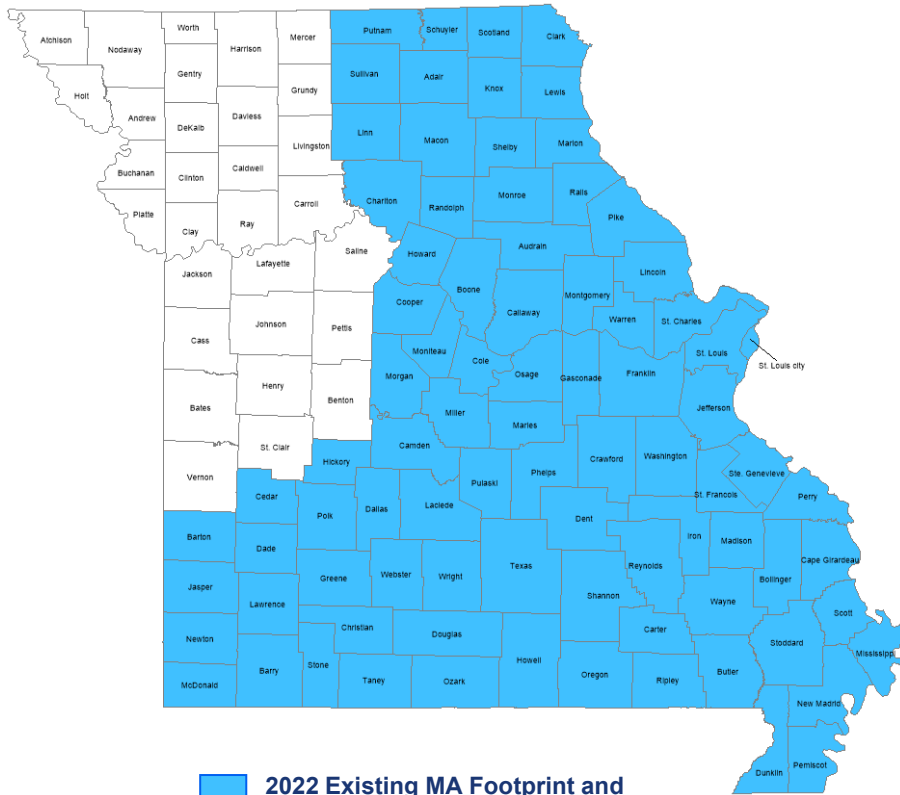

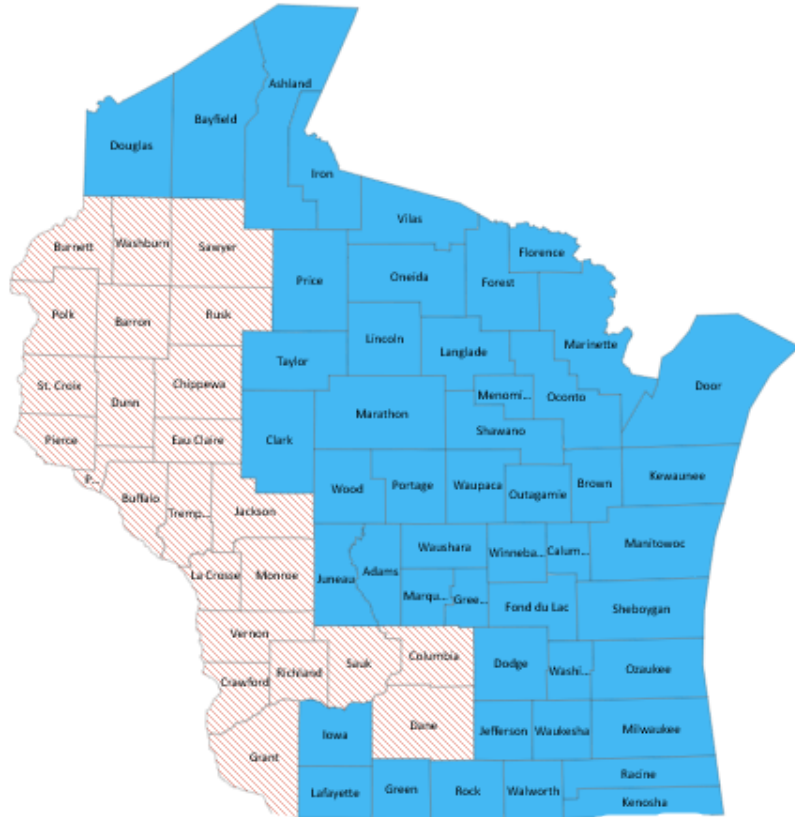

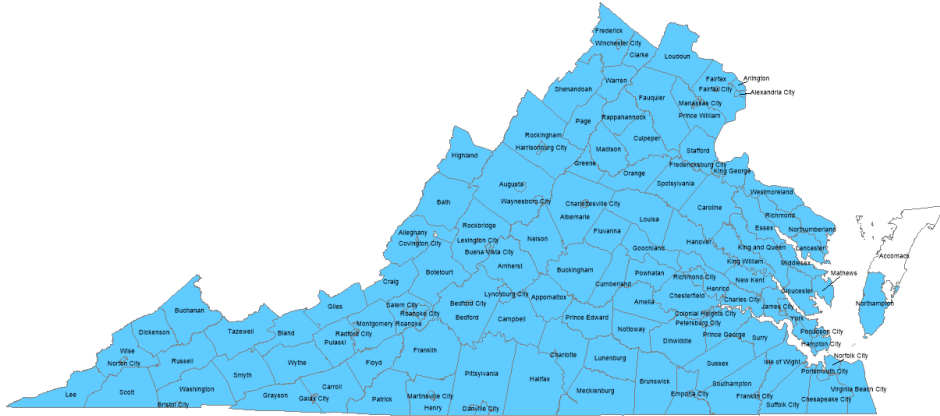

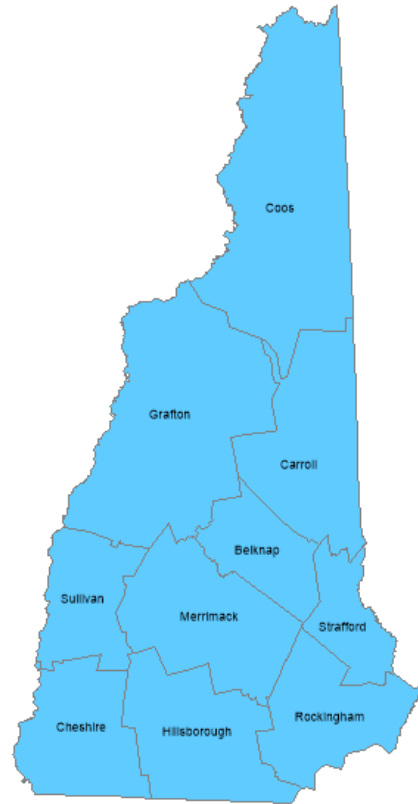
